

I would like to bring to your kind notice that GJC has declared its Elections for Committee of Administration (COA) i.e. GJC Elections 2018. List of eligible voters has already uploaded on website of GJC i.e. www.gjc.org.in. Members are requested to check their eligibility to participate in GJC Elections 2018 by downloading the Eligible Voters List from GJC website.

If in case you are not able to check your name in the list of eligible voters you are requested to kindly contact GJC office at 022-67382727.

Any addition/amendment or deletion in the voter list shall not be entertained after 26.11.2018 the date already notified in the election schedule.

The elections shall be held for the 9 vacancies announced in 7 respective panels including election of Zonal Chairmen i.e. West, South & East zones. The same are as follows:-

The election for the post of three Zonal Chairman (West, South & East Zones) shall take place before the election other members for the Panels. Nominations for the post of Zonal Chairman (West, South & East Zones) will only be accepted from the abovementioned notified panels. In case zonal chairman is selected from the reserved panel that has only one vacancy it shall be deemed to be filled from the respective panel as well.

Nomination for aforesaid vacancies shall be considered as per AOA and reservation rule applicable prescribed in the AOA and election rules.

Members please note that this is an electronic voting system and there is no human intervention involved in the voting system. Members has to use their registered 10 digit mobile number and a valid membership number available in our records to cast their votes in GJC Elections 2018. Eligible members who wish to contest for the COA, has to submit the duly filled COA Nomination form available on website of GJC, duly filled Affidavit with all the necessary documents along with enrolment fees of Rs. 5,000/- and a refundable deposit of Rs. 20,000/- (which will be refunded after the GJC Elections 2018 are done) in favour of "All India Gem and Jewellery Domestic Council" to be paid by way of Cheque/NEFT.
