GJF has planned to hold **Regional Round Table Conferences across 4 regions** with the specific objective to improve the understanding of the industry issues and addressing the same by the findings and conclusions of this conference. The 1st RTC was held in Hyderabad on the 7-8 Oct 2015 with top industry leaders and business leaders. We shall also be going a step forward to over time prepare a Vision Document sharing our concerns and a positive roadmap for the future which has been shared with the industry and the Govt.

GJF has consistently **connected with the press** to ensure that the industry's concerns are leveraged with the business environment and public at large. Towards that end, press conferences were held in 19 cities on the same day, to create awareness and mobilise support on the Pan card issues.

The establishment of the **National Council for the gems and jewellery industry** has long been my cherished ambition which I share with my colleagues at GJF. We are relentlessly pursuing this goal, which when achieved will be a landmark achievement for all of us.

ELECTIONS

We intend to conduct elections which is not far away now as the new COA shall be elected by the general body of all members around the end of this year. We are looking at a fair and transparent elections and wish active support and participation from all members.

I would always like to put in more efforts towards creating a conducive and dynamic environment for our members. In the past year, we have launched several initiatives to build stronger relations with our members, have a ground level understanding of their concerns and create sufficient opportunities for meaningful communication between all of us.

- ◆ **National Jewellery Awards** was given a new flair, for the first time, whereby 10 students received scholarship of 1.5 lac each courtesy GJF to pursue higher education.
- ◆ **GJF Nite** continued to entertain and celebrate the art in jewellery with renewed vigour and enthusiasm.
- ◆ **TrustMark** is a business excellence model that aims to build an organized industry that earns its rightful place in the business environment,
- ◆ **Labham** is an educational initiative that seeks to improve the business model and efficiency of jeweler businesses at a more minute level. This programme shall be rolled out again soon.
- ◆ **Star Scheme** is a skill development programme that GJF is executing in cooperation with GJSCI under the auspices of the Government of India. So far in 16 weeks since its Initiation 91 centres have been covered and more than 2014 trainees have been trained.
- ◆ **Under Fellowship Programme**, 1 trip was planned for its members to the Las Vegas Show in the first quarter of 2015.
- ◆ **Abhusanam** – Regional B 2 B Buyer Seller Meet has been successfully held at Raipur and in Nagpur in the month of Oct 2015.
- ◆ **Jewellers ID Card**: successfully launched in the month of February 2015 during the grand finale of National Jewellery Awards.

My aim as Chairman for the short period till the elections is make has been to ensure thorough professionalism, constant efforts to improve our services and create more value for our members and to clear all compliance issues. 16. Significant accounting policies and Notes forming part of the financial statements for the year ended 31st March 2015

1. Corporate information.

The company was incorporated on July 22, 2005. The main object of the company is to promote, aid, help, assist and encourage the advancement and furtherance of local and inland trade in gold jewellery, diamond jewellery, silver jewellery etc. by providing all types of training, information and knowledge to the manufacturers and traders, in jewellery of all types, size and varieties, its industry, trade and commerce with the aim of creating a healthy atmosphere amongst the members without any motive of making profit.

2. Significant accounting policies.

2.1 Basis of accounting and preparation of financial statements.

The financial statements of the Company have been prepared in accordance with the Generally Accepted Accounting Principles in India (Indian GAAP) to comply with the Accounting Standards specified under Section 133 of the Companies Act, 2013 read with Rule 7 of the Companies (Accounts) Rules, 2014 and the relevant provisions of the Companies Act, 2013 ("the 2013 Act") / Companies Act, 1956 ("the 1956 Act"), as applicable. The financial statements have been prepared on accrual basis under the historical cost convention. The accounting policies adopted in the preparation of the financial statements are consistent with those followed in the previous year except as mentioned in Note 3.8 in the Notes to accounts.

2.2 Use of estimates.

The preparation of the financial statements in conformity with Indian GAAP requires the Management to make estimates and assumptions considered in the reported amounts of assets and liabilities (including contingent liabilities) and the reported income and expenses during the year. The Management believes that the estimates used in preparation of the financial statements are prudent and reasonable. Future results could differ due to these estimates and the differences between the actual results and the estimates are recognised in the periods in which the results are known / materialise.

2.3 Inventories.

There are no inventories. Consumables like stationery items are treated as revenue expenses during the year and therefore inventory is not maintained.

2.4 Fixed Assets.

Fixed assets are stated at cost, less accumulated depreciation / amortisation. Costs include all expenses incurred to bring the asset to its present location and condition.

2.5 Depreciation on Tangible Assets.

Depreciable amount for assets is the cost of an asset, or other amount substituted for cost, less its estimated residual value. Depreciation on tangible fixed assets has been provided on the written down value method as per the useful life prescribed in Schedule II to the Companies Act, 2013. Fixed assets exclude assets individually costing Rs 5,000 or less which are not capitalised except when they are part of a larger capital investment programme.

Significance of Accounts



2.6 Revenue recognition.

Revenue earned is recognized in the books when there is reasonable certainty in collection thereof and in cases of reasonable uncertainty its recognition is postponed till ultimate collection.

Receipts / Donations towards the corpus are capitalised and accounted on the date of receipt. Interest income is accounted on accrual basis.

The company is recognising the income from the event 'Preferred Manufacturers of India' (PMI), on the basis of proportionate budgeted expenses and total budgeted expenses.

2.7 Foreign currency transactions and translations.

Transactions in foreign currency are recorded at the original rates of exchange in force at the time the transactions are effected. At the year-end, monetary items denominated in foreign currency and forward exchange contracts are reported using closing rates of exchange. Exchange differences arising thereon and on realization/ payment of foreign exchange are accounted, in the relevant year, as income or expense.

2.8 Investments.

Current Investments are carried at the lower of cost or quoted/ fair value, computed category wise. Long term investments are stated at cost. Provision for diminution in the value of long term investments is made only if such decline is other than temporary.

2.9 Employee Retirement benefits.

a. The Company contributes towards Provident Fund which is defined contribution retirement benefit plan for eligible employees. Liability in respect thereof is determined on the basis of contribution as required to be made under the statutes/rules.

b. Gratuity liability, a defined benefit scheme, and provision for compensated absences are accrued and provided on actual basis.

2.10 Provisions, Contingent Liabilities and Contingent Assets

A provision is recognized when the Company has a present obligation as a result of a past event, for which it is probable that cash outflow will be required and a reliable estimate can be made of the amount of the obligation. A contingent liability is disclosed when the Company has a possible and present obligation where it is not probable that an outflow of resources will be required to settle it. Contingent Assets are not recognized in the financial statement.

2.11 Service tax input credit

Service tax input credit is accounted for in the books in the period in which the underlying service received is accounted and when there is reasonable certainty in availing / utilising the credits.

The company, pursuant to Special Resolution passed on 7th September 2014 amended its Articles of Association which has also been duly approved by the Registrar of Companies, Maharashtra, Mumbai, vide its letter dated 15th April 2015. The amended Articles of Association has interalia enhanced the total strength of directorship that could be appointed by the company and has deleted the restriction on maximum number of members.

The Board shall, at the upcoming Annual General Meeting, undertake necessary compliances with respect to appointment and retirement by rotation of its directors in due compliance of the Act and provisions of its amended Articles of Association. The said non compliances may be legally challenged besides attracting penal provisions of the Act in relation to which the financial and accounting implications cannot be presently ascertained.

3.8 The company, earlier, was recognising income from its event, 'Preferred Manufacturer of India' (PMI), on the basis of proportionate actual expenses and balance budgeted expenses, however in the current financial year the company has changed the accounting policy and

is recognising the income from PMI on the basis of proportionate budgeted expenses and total budgeted expenses due to which the Income recognised from PMI in Income and Expenditure account is higher by Rs 14,01,295 and consequently the excess of expenditure over income is under stated by Rs 14,01,295.
