**Subject: All India Gem and Jewellery Domestic Council (GJC) Election 2024 for Committee of Administration (COA) i.e. "GJC ELECTION 2024"**

I would like to bring to your kind notice that GJC has declared its Election for Committee of Administration (COA) i.e. GJC Election 2024 on 21<sup>st</sup> November, 2024. List of eligible voters has already been uploaded on website of GJC i.e. [www.gjc.org.in](http://www.gjc.org.in). Members are requested to check their eligibility to participate in GJC Election 2024 by downloading the Eligible Voters List from GJC website.

In case you are not able to check your name in the list of eligible voters you are requested to kindly contact GJC office on [022-67382700](tel:022-67382700) during working hours between 10 a.m. to 6 p.m. from Monday to Saturday.

Any addition or deletion in the voter list shall not be entertained as notified in the election schedule.

The elections shall be held for 8 vacancies announced in 4 respective panels including election of Zonal Chairmen South Zone. The same are as follows:-

The results of the election for the post of Zonal Chairman (South Zone) shall take place before the election results of all other members for the Panels are declared. Nominations for the post of Zonal Chairman (South Zone) will only be accepted from the abovementioned notified panels. In case Zonal Chairman is selected from the reserved panel that has only one vacancy it shall be deemed to be filled from the respective panel as well.

Nomination for aforesaid vacancies shall be considered as per Articles of Association (“AOA”) of the GJC and reservation rule shall be applicable as prescribed in the AOA and election rules.

Please note that this is an electronic voting system and there is no human intervention involved in the voting system. Members has to use their registered 10 digit mobile number and a valid membership number available in our records to cast their votes in GJC Election 2024. Members are requested to download the following documents from the website of GJC i.e. [www.gjc.org.in](http://www.gjc.org.in)

1. Election Rules of GJC;
2. GJC COA Nomination Form; and
3. Draft Affidavit-Cum-Indemnity Bond

Eligible members who wish to contest for the position of COA must submit the following documents:

- a. A duly completed COA Nomination Form which is available on the website of the GJC.
- b. A notarized Affidavit-Cum-Indemnity Bond, printed on non-judicial stamp paper of Rs. 500/- or with a stamp duty of Rs. 500/- paid by way of franking.
- c. All required supporting documents.
- d. Payment of an enrolment fee of Rs. 5,000/-.
- e. A refundable deposit of Rs. 20,000/-, which will be refunded upon completion of the GJC Elections 2024.

The payment of both the enrolment fees and refundable deposit must be made in favour of “All India Gem and Jewellery Domestic Council” by way of DEMAND DRAFT payable at Mumbai or via NEFT. The NEFT Account details are provided below:

The email application must be received no later than **5.00 p.m. on or before 30th November, 2024**. Members submitting their application via e-mail must also attach a copy of the courier receipt or postal acknowledgement as evidence that the original documents have been dispatched. The original physical documents must reach the GJC office in sealed envelope by **1<sup>st</sup> December, 2024**. Applications received after 1<sup>st</sup> December, 2024 will be rejected.

Please note that e-mails received after 30<sup>th</sup> November, 2024 will not be accepted under any circumstances. Members are strongly advised to carefully read the Election Rules of the GJC before submitting their application for the GJC Election 2024.

**Please Note:**

1. There will be no election for Zonal Chairman (East, West & North Zone), Medium Manufacturer-Jewellery Panel, Small & Medium Manufacturer Silver Jewellery & Small & Medium Manufacturer Colour Stones & Allied & Precious Metal Bullion & Refinery & Lab Grown Diamond Panel, Small Manufacturer Jewellery Panel, Large Manufacturer Diamond & Large Manufacturer Jewellery Panel, Small & Medium Wholesaler Panel since there are no vacancies under the said Zones and Panels.
2. There is no enrolment fees for casting your vote.
3. PAYMENT BY CHEQUE WILL NOT BE ACCEPTED.

4. Members shall submit their Nomination Form, along with duly stamped and notarized Affidavit-Cum-Indemnity Bond and all other required documents, by or a **recognized courier service**.
