

ELECTION RULES

FOR THE ELECTION OF THE

COMMITTEE OF ADMINISTRATION (COA), CHAIRMAN AND VICE CHAIRMAN

OF

ALL INDIA GEM & JEWELLERY DOMESTIC COUNCIL, 2022

In exercise of power conferred under Article of Association of the All India Gem & Jewellery Domestic Council, the Election Committee with the Committee of Administration hereby makes the following rules applicable for Elections 2022, namely:-

1. Short title and Commencement:-

- 1.1. The rules may be called the Election Rules ("Rules") for the election of the Committee of Administration (COA), Chairman and Vice Chairman of All India Gem & Jewellery Domestic Council, 2022.
- 1.2. Rules shall come into force from the date of adoption in the meeting by the Committee of Administration.
- 2. **Definitions:** In these rules, unless the context otherwise requires:
- 2.1. "Act" means the Companies Act, 2013 and includes any statutory modification, amendment or re-enactment thereof, for the time being in force.
- 2.2. "Article" means an article forming part of articles of association of the All India Gem & Jewellery Domestic Council.
- 2.3. "Committee" means the Committee of Administration (COA) of All India Gem & Jewellery Domestic Council, constituted, as such, under the articles of All India Gem & Jewellery Domestic Council.



- 2.4. "Combined Panel" means panels amalgamated together based upon the number of members in accordance with the Articles.
- 2.5. "Eligible Voters List" means the list of members included in the voter list entitled to cast vote in the election process of the Committee.
- 2.6. "Email" or "Email Address" means E-mail address of the member as provided by the member, available and registered with the GJC and displayed on the GJC website against the name of the member in the "Eligible Voter List".
- 2.7. "Electronic Agency" means the team/agency appointed by the Election Committee of GJC to conduct the process of voting by electronic means under the present rules; Election Rules for the election of the Committee of Administration (COA), Chairman and Vice Chairman of GJC, 2022.
- 2.8. "Election Committee" means the committee formed by COA for framing election rules and managing and conducting elections.
- 2.9. "Election Rules" means the rules framed by the Election Committee and adopted by the COA in its meeting.
- 2.10. "Member" means the ordinary member of the GJC.
- 2.11. "Membership Number" for the purposes of the election shall mean the membership number of the Member, displayed on GJC website against the names of the member in the "Eligible Voter List".
- 2.12. "OTP" means computer generated one time password during online voting process forwarded on the registered mobile number of the member maintained with GJC.
- 2.13. "Returning Officer" means a person appointed by COA upon recommendation of election committee and entrusted to conduct the election of COA.



- 2.14. "Year" means the financial year beginning with the 1st April and ending with the 31st March.
- 2.15. Words and expressions used herein and not defined but defined in the Article shall have the meaning respectively assigned to them in the Article.

3. Role of the Election Committee:

- 3.1 The Election Committee (EC) shall be formed by the COA as an independent committee and the members of the Election Committee shall not be eligible to contest the election. The EC shall appoint the Returning officer and Election Agency. The EC shall apprise them of their role in the elections and assist them on the structure of GJC and the procedure to be followed for conducting elections. Additionally, the EC shall formulate and provide them with the rules and regulations of the elections.
- 3.2 The EC shall consist of members of the Gems & Jewellery industry and /or members of GJC who shall operate independently.
- 3.3 The Election Committee shall conduct EC meetings of the appointed members only and make necessary changes/amendments as may be required and within the framework of amended Articles of Association of the GJC in the existing election rules framed and recommend the same to the COA for their adoption.
- 3.4 The EC has the right to invite the assistance of any consultants, lawyers, COA or any GJC management person as may be required by them in their meeting.
- 3.5 The members of the EC along with the appointed Returning Officer will be required to attend COA meetings where the matters of the EC recommendations and election rules presented to COA by way of a report sent for adoption.



- 3.6 The EC may ask for information and documents for reference and take assistance of the GJC management /staff in all matters as they may think necessary and the GJC office shall provide their assistance.
- 3.7 The EC shall not share or be required or compelled to share any information it shall prepare for the ensuing elections to any one unless the EC desires to do so. The EC shall place before the COA final report/election rules in their joint meeting with the COA for their approval and adoption.
- 3.8 The final cut-off date for eligibility of members shall be declared by the EC. All such members whose names appear in the compliant members' list on the cut-off date shall become eligible as voters for the elections. Such a list shall be applicable for all eligible members, capable of voting and standing in the elections, as found appropriate to them. The list of the eligible voters circulated by the GJC office to all members by email and shall be posted on the GJC website. This cut-off date shall be 31st March, 2022 for this election.
- 3.9 The COA shall instruct the GJC office / secretariat to provide full administrative, legal and personal support to the EC and the Returning Officer for the entire period of the Elections and no information shared shall be passed on to or with any other person in GJC.
- 3.10 The COA shall provide for sufficient funding and shall pass the necessary resolution with regards to Election Budget in their COA meeting.

4. Role & Power of the Returning Officer:-

4.1 Returning Officer (RO) shall be an independent person with past knowledge and experience of managing elections, to be appointed by the EC selected from a minimum of 3 applications received by EC. In case of insufficient applications received the decision of the EC shall be final.



- 4.2 Returning Officer shall be the supreme election authority who will ensure the secrecy of electoral rolls, all data, voter details, confidentiality of all information owned by GJC and not use this for any personal benefit.
- 4.3 Returning Officer shall supervise the 'Electronic voting agency' during the Election Process.
- 4.4 All the queries/complaints related to the Election sent by the members and COA shall be referred to Election Committee Convenor & GJC Secretariat. The Election Committee Convenor will try resolving the same after consultation with Returning Officer.
- 4.5 Returning Officer shall assume / hold office till the elections are conducted, and the new Committee is elected and till the first meeting of new COA takes place.
- 4.6 Returning Officer shall approve and publish the schedule and all related matters including the Code of Conduct published for the elections and election process on the website of GJC in consultation with the EC and which shall also be communicated to members through electronic communication via email or SMS on their mobile numbers respectively registered with the GJC.
- 4.7 The EC shall apprise and notify the Returning Officer of the number of vacancies identified by them, and confirm the final list of Panels and Zonal Chairman where elections shall take place arising out as prescribed in the AOA.
- 4.8 In the event if the Returning Officer having reasons to doubt the veracity of any of the particulars/information contained in any Nomination Form received, it may call for particulars/information from the office of GJC. The Returning Officer will also be at liberty to direct the EC to call for any documents from the respective member(s) for verification.



- 4.9 Returning Officer shall enter the names of the nominee panel-wise, in his Register and after due scrutiny, prepare list of valid and rejected nominations from all the nominations received. The Returning Officer shall ensure that lists of valid and rejected nominations along with the reasons of rejections is displayed on the website of GJC without any delay.
- 4.10 The Returning Officer shall with the help of EC and GJC office, dispatch a notice via registered email or by SMS on mobile number of the eligible members informing them about the electronic voting system and the procedure to be followed for voting.

5. Process of assessing vacancies in 2022:

- 5.1 The vacancies for each term have to be assessed in coordination to the GJC AOA and the Companies Act, 2013 and must be conferred and authenticated by a Legal consultant.
- 5.2 **Mandatory Retirement:** In pursuance to article 33.8(b) of the AOA, any member of the COA who has served for continuous period of six years on the COA, would be required to mandatorily retire and shall not be eligible for reelection. The interpretation of what is excluded from the calculation of a continuous period of six years would be as provided in the AOA.
- 5.3 **Retirement by Rotation:** In pursuance to article 33.8 (a) of the AOA, one third of the members of the COA are required to retire by rotation. Further, in pursuance to Companies Act, 2013, the longest serving COA members should first be considered for retirement. Such members who would be eligible for retirement would be determined through a draw of cards. Their names shall be determined by EC. The Returning Officer shall hold the draw of cards in the presence of the COA. The said draw can be conducted live or on a digital video platform, headed by the Returning Officer, who shall conduct the draw of cards and be at liberty to adopt all such measures to ensure a fair and transparent



draw of cards. All COA members who were elected/ re-elected and appointed in 2020, would not participate in the draw of cards and would continue to be members of the COA. All COA members who have been elected and appointed prior to 2020 (other than those who are required to mandatorily retire or vacate their position or those who have already resigned), will participate in the draw of cards to determine who will retire by rotation.

- 5.4 Additional Vacancies: In addition to the above mentioned vacancies on account of retirement, there will be the following two (2) additional vacancies
 1 seat of Chairman, 1 vacancy due to resignation of Mr. Krishna Goyal, COA member.
- 5.5 Accordingly, in pursuance to the above, the number of COA members who will have to retire by rotation would be $1/3^{\rm rd}$ of 18, being the total number of elected members, i.e. 6 COA member. Out of such 6 COA members, 3 members would be mandatorily retiring by rotation. Therefore, through the draw of cards 3 additional COA members would be identified for retirement by rotation. In addition, there are 2 additional vacancies that would be required to be filled. In all, there will be an election for a total of 8 COA members.
- 5.6 The Returning Officer shall declare the list of the retiring COA members. Any change to the final list of vacancies arising out of the retirement of the member shall be determined by Returning Officer post approval of the Election Committee, in accordance with articles and the present rules.

The Chairman will vacate the post as Zonal Chairman-West and become IPC.



6. Election of Zonal Chairman:-

- 6.1 Zonal Chairman as mentioned in Articles will be elected by the members from the 4 zones respectively.
- 6.2 The Zonal Chairman's tenure is similar to any other COA as prescribed in the AOA.
- 6.3 In case of any vacancy that arises out of the premature retirement of a ZC, post elections the same shall be filled from the respective zone and Panel by the COA. The COA can nominate and elect from the existing COAs from the respective Zone to replace the vacancy created. The term will be as per the AOA.
- 6.4 The post of the Zonal Chairman shall be filled prior to the COA in accordance with the articles and the election rules applicable for the time being in force.
- 6.5 The EC shall declare the Seats that shall be available for the election post determined by the RO to all members.

7. Representation to the Committee by Group of Panels/Combined Panels:-

- 7.1 Subject to the articles and based upon the membership register of GJC, the numbers of the representations from panels and combined panels shall be as follows: Sr. No. Panels/Combined Panel Allocation of reservation as per article based upon the membership number (Rounded off) Original/Combined.
- 7.2 The numbers of seats to be filled in the election shall be identified and notified by Election Committee considering number of positions lying vacant and the one third number of the existing members of COA who would retire by draw of card.



7.3 While identifying the number of vacancies to be filled in the COA the Election Committee shall keep the reservation of representation from Zones and panels/combined panels as stipulated in Articles and Rule 5.1 mentioned herein above.

8. Retirement and Election of Member To the Committee of Administration:-

- 8.1 Returning Officer in consultation with election committee and with the support of Election agency shall ensure the expeditious process of the election in accordance with articles for the vacancies identified by the EC.
- 8.2 The date of the election shall be fixed by the election committee in consultation with Committee of Administration (COA) of the GJC in the second quarter of the term ending year in a manner that the elections should be conducted and results achieved well before the 31st December.
- 8.3 In the first meeting of the COA of newly elected members, a joint meeting of new and outgoing COA shall be called. The existing Chairman would ensure that some experienced COA member or past Chairman of GJC conduct the orientation of the incoming COA members of the structure of GJC and explain their rights, systems of operation and duties to be performed.
- 8.4 Besides taking the charge from the outgoing COA, the outgoing Chairman shall assist the election of the new Chairman and Vice Chairman in accordance with the EC rules and as specified in the AOA. The outgoing Chairman shall ask the COA to propose the names of candidate for Chairman and Vice Chairman. In case there are more than one nominations received from COA members for any post, the winner shall be decided by way of a vote by secret ballot and the name shall be declared by the outgoing Chairman.
- 8.5 Once both the Chairman and Vice Chairman are elected their names shall be declared by the outgoing Chairman. This process of election of Chairman and



Vice Chairman can also be conducted on any digital video conferencing platforms and must be recorded. The RO shall be witness and observer to this meeting.

- 8.6 Election would be conducted from the Panels having no representation, combined panels, the seats declared unreserved and occupied by members appointed by 'Committee' on account of casual vacancy. All casual vacant seats shall be filled as per articles.
- 8.7 Notwithstanding anything herein, if there arises a vacancy in the Committee due to non-receipt or withdrawal of nomination at the time of election, as the case may be, such vacancy shall be filled in by the Committee in its first or subsequent meetings following the election. A person appointed to fill up such a vacancy shall hold office only for a period of 2 (two) years till the subsequent election of the Committee as per AOA.
- 8.8 The GJC office on the instructions of the Returning Officer shall with prior intimation through Email or SMS on the registered mobile number of the Committee members and entire member base shall formally call upon such members or their authorized representative, to remain personally present at the place or at the virtual platform and time during the process of draw of card.
- 8.9 The Returning Officer shall notify the result of draw of cards to the office of the GJC formally signed by him.
- 8.10 The existing Chairman term ends on 31st December after the 2 years term, but the outgoing Chairman shall continue to be the Chairman after the completion of elections till a formal takeover/handover is made by the incoming Chairman in the first COA meeting post elections.



9. Election Process: - As per the notified schedule:-

- 9.1 Eligibility: Ordinary Members (Annual and Life Members), new and old, who have completed all the formalities of membership and paid their full subscription of applicable membership fees, and membership application are approved by COA within time frame of 3 months as prescribed in AOA, on or before the end of the cut-off date declared by the EC, shall be called eligible members and they shall have the right to vote and contest the election of Committee.
- 9.2 The eligible list of names as approved by EC shall be approved by the COA to be included in the declared 'eligible voters' list along with the Code of Conduct and all necessary guidelines issued by the EC.'
- 9.3 The GJC office upon preparation of Eligible Voters List, approved by the EC and the Returning Officer shall notify to all ordinary members through e-mail and SMS on their registered email and mobile number, about the availability of the list of all Eligible Voters for inspection at the head office of the GJC as well as on the website of GJC.
- 9.4 The authorized representative of the member whose name is mentioned as such in the membership application submitted to the GJC shall have right to vote at the election through their IP address only.
- 9.5 GJC COA must ensure that the Election Rules and the Code of Conduct and all guidelines issued by the EC are effectively implemented by the members and report to the EC of any contraventions of the same.



10. Rules for voters:

- 10.1 Voters must vote from their own IP address only unless they are travelling.
- 10.2 If Multiple votes are received from one IP address then the said votes will be considered invalid and the same will be rejected by the election agency.
- 10.3The representative of an Ordinary Member of the GJC can represent only one firm or company and only one Panel, irrespective of the number of their family firms that may also be members with GJC.
- 10.4 Each member and each representative shall have the right for one vote each for every single representation for the respective Panel as opted at the time of admission.
- 10.5 The members of a panel that are not sufficient to form a Panel shall not be eligible to vote for those panels however they will have the right to vote for their respective Zone only.
- 10.6 The members representing Panels that are merged to form a combined panel shall vote for that combined panel collectively.
- 10.5 The inference and decision of the RO and EC shall be final and cannot be disputed.



11. Rules for Candidates:

A candidate contesting for any position in the election of the 'Committee' must fulfill the following eligibility criteria: -

- 11.1 A candidate must be the Ordinary Member of the GJC as listed in the list of eligible voters.
- 11.2 Only the authorized representative of any member as mentioned in the membership application form submitted to the GJC shall be entitled to contest and vote in the Election.
- 11.3 No candidate can stand in elections from more than one Panel. All candidates must fulfill the criteria prescribed under the Election Rules and AOA.
- 11.4 All candidates who are in violation of the Companies Act, 2013 where the ROC has barred them for such violation as a Director in any company will not be entitled to contest the elections in any capacity. Also any candidate who incurs disqualification as specified in article 8 of the AOA shall not be eligible to contest or cast vote in the election.
- 11.5 A nomination is required for every candidate indicating the name of the authorized representative of the Member eligible for election to any Panel of the Committee of Administration shall be proposed and seconded by members of the same Panel or every applicant contesting for the Panels.
- 11.6 In the event of nomination for Zonal Chairman, the same shall be proposed and seconded by members from any Panel of the same Zone. The nominee, proposer and seconder of all contesting candidate should be eligible to vote.
- 11.7 All the contesting candidates shall submit their applications duly filled in with the original Nomination Form 'A' as attached as per the approved Election Rules of that year, for the election of the Committee of Administration (COA), along with the prescribed fee and security deposits as determined as per the schedule



notified by the returning officer before the prescribed last date of submission. Any applications received after the prescribed last date or receipt of any incomplete applications shall be treated as invalid.

- 11.8 All nomination forms have to be submitted by post to GJC office addressed to Returning Officer or by email on the prescribed email id provided for the same in each elections along with all relevant attachments as prescribed in the Rules and the schedule.
- 11.9 Any Nomination forms submitted by telex/fax/telegram/or any electronic mode to the Returning Officer shall be treated as invalid.
- 11.10 Any candidate will be permitted to withdraw its Nomination by a written communication sent to returning officer at the office of GJC or through their registered e-mail of the Returning Officer as per the notified schedule published on the GJC Website.
- 11.11 Withdrawal of nominations sent on the official designated email-id from the registered email-id of the candidate will be considered valid and acceptable by the Returning Officer. Such withdrawal shall be final and no subsequent request, for rescinding such withdrawal shall be accepted or entertained by the Returning Officer.
- 11.12 A member cannot file nomination and contest election for Zonal Chairman as well as for Panel Member simultaneously.
- 11.13 Election shall be held for the Zonal Chairman and the Panels/Combined Panels as per the Articles.



12. Process of declaration of results:

12.1 The results of elections shall be declared at a specified venue in the city of GJC's Head Office or on a digital platform easily accessible to most members and as approved by the EC and the Returning Officer.

12.2 The GJC office shall maintain an official record of all the names of all the candidates and votes received and have the Chairman finally sign the note before the end of the meeting. GJC office shall finally inform all its members of the names of winning candidates Zone and Panel wise by email and publish on GJC website.

12.3 The results of elections of the Zonal Chairman shall be declared before the results of the candidates standing for Panels are declared at time of declaration of results of the Election.

12.4 In case a Zonal Chairman get elected but his Panel exceeds maximum vacancy on his panel, one who has obtained the least percentage in his respective zone shall automatically be eliminated. A member cannot file his candidacy from a panel for the post of Zonal Chairman if there are no vacancies on his panel.

12.5 Once the election of Zonal Chairman is completed, election for all Panels /combined panels shall commence by way of draw of cards. In such draw the Returning Officer will seek the name of the candidate who has secured highest number of votes in that panel from the election agency in sequence of highest votes. The information of votes received by all candidates from the notified panels/combined panels will be kept ready by election agency.

12.6 The cards of all notified panels/combined panels will be placed in a covered box from which the Returning Officer will remove one card at a time and call out the name of the panel to which the election agency after required verification will declare the name of the candidate who has secured the highest number of votes. It is important to note that first the results of all notified panels/combined panels shall be called out by the Returning Officer in Round 1 of draw of cards.



12.7 In case there are any vacancies available in any panel there will be a Round 2 or Round 3 in which panel cards shall be drawn by the RO for each panel one by one. If all the vacancies of all notified panels/combined panels have been filled and a candidate's name is declared then that panel will not be called out for subsequent rounds.

12.8 For example: In case, there is an 8th winning panelist from a particular Zone that has its full quota of 7 elected, the candidate with second highest % votes from a different zone shall be nominated, as defined in the election rules. During draw of cards by the Election Authority, the contestant of this panel securing majority of votes will be considered in the first round of draw of cards.

The contestant securing the second highest votes will considered in the subsequent draw of cards, provided there is vacancy in the candidate's zone at the time when the card is being pulled out by the Election Authority.

All panel candidates, irrespective of the fact that they have contested and secured maximum votes have to go through the second stage of election process i.e. draw of cards.

In case there is even 1 seat and 1 candidate has contested, this does not assure an automatic nomination. This is due to the constraint arising out of number of available seats per zone. (Maximum 7)

This process of "draw of cards" is being conducted to adhere to the principle of fair and natural justice as defined by the election rules. All panel candidates, irrespective of the fact that they have contested and secured maximum votes have to go through the second stage of election process i.e. draw of cards.

In this case, the candidates name will be considered for the random sequence of draw of cards, which will be derived by the Election Authority.

12.9 If there are no candidates for a notified panel/combined panel and if 20 members are not available/eligible/elected to the COA then that vacancy for that panel/combined panel will be declared as unreserved and will be filled up by the COA in due course in accordance with provisions of Articles.



- 12.10 In case only one valid nomination is received for any one vacancy, then there will be no election for that vacancy/post and the nominee will be declared as elected and the nominee declared unopposed & elected shall not go under draw of cards. Provided the vacancy is available in the respective zone after the election of Zonal Chairman.
- 12.11 Each Voter Member shall follow the procedure of Electronic Voting as specified in the Notice to cast its vote. All eligible Voter Member shall be entitled to cast their respective votes as per notified schedule.
- 12.12 The electronic votes cast by the members shall be stored in a secure server. Only the Returning Officer shall be allowed access to the said votes after the voting has ended and votes are ordered by the EC to be retrieved.
- 12.13 The total count of votes on the server will be noted and verified by the Returning Officer through his access to the secure sever where the votes have been stored.
- 12.14 In case of a dispute in the count of votes a candidate may make an application for a scrutiny & the application should be made to EC.
- 12.15 The Returning Officer shall maintain secrecy of the votes received. Only the Returning Officer or a person authorized by him in writing, and the candidate or a person authorized by him, shall be allowed to observe the process of scrutiny and counting of voting results at the office of GJC.
- 12.16 The person receiving the highest number of votes from each Panel / Zone will be declared as elected from the respective Panel / Zone.
- 12.17 In the case of a tie, the result will be determined by a draw of cards amongst the tied candidates by the Returning Officer.



12.18 The Returning Officer shall declare the election result stating the names of elected candidates from each Zone and Panel as per Election Rules of the year for the election of the Committee of Administration (COA).

12.19 The decision of the Returning Officer in this regard shall be final and binding on all concerned.

12.20 The Election results will be displayed at the website of GJC and shall be communicated to all members by way of E-mail on the registered E-mail ID and/or through SMS on the registered mobile number of the member.

13 Manner of declaring results:-

13.1 The agency that manages the e-voting process called the Electronic voting agency shall get its process audited independently and approved by the Security Auditors and submit the certificate issued by the Security Auditor or equivalent certified agency with the Returning Officer and EC.

13.2 The Voting agency will determine from their servers the total number of Votes received for each Zone and Panel and the number of Votes secured by each of the contesting candidates along with the name of the candidate securing the highest number of votes and declare results and hand this over in a signed and sealed envelope to the RO.

13.3 The RO shall then declare the names of each contestant starting from 4 ZC's and then Panel-wise and declare the name of the winning candidate based on the election rules, from the draw of cards in Round 1-2-3 as required.

14. Dispute Resolution:-

All disputes with regard to any matter arising out of the election of the Committee of Administration, Chairman and Vice Chairman of the GJC shall be resolved by way of arbitration of a sole Arbitrator mutually appointed by the contesting parties, in accordance with the Arbitration and Conciliation Act, 1996 as may be



amended from time to time. The decision of the arbitrator shall be final and binding on all the parties. The seat and venue of the arbitration proceedings shall be conducted at Mumbai and shall be in English language.

The Courts at Mumbai shall have jurisdiction for all purposes.

15. Representation to the Committee by Panels/Combined Panels with No. of Members and allocation of seats and vacancies as per Articles of Association:
