I would like to bring to your kind notice that GJC has declared its Election for Committee of Administration (COA) i.e. GJC Election 2020 on 5<sup>th</sup> December, 2020. List of eligible voters has already been uploaded on website of GJC i.e. [www.gjc.org.in](http://www.gjc.org.in). Members are requested to check their eligibility to participate in GJC Election 2020 by downloading the Eligible Voters List from GJC website.

If in case you are not able to check your name in the list of eligible voters you are requested to kindly contact GJC office on [022-67382700](tel:022-67382700) during working hours.

Any addition/amendment or deletion in the voter list shall not be entertained as notified in the election schedule.

The elections shall be held for the 9 vacancies announced in 8 respective panels including election of Zonal Chairmen i.e. South & East Zone. The same are as follows:-

The results of the election for the post of two Zonal Chairman (South & East Zone) shall take place before the election results of all other members for the Panels are declared. Nominations for the post of Zonal Chairman (South & East Zone) will only be accepted from the abovementioned notified panels. In case Zonal Chairman is selected from the reserved panel that has only one vacancy it shall be deemed to be filled from the respective panel as well.

Nomination for aforesaid vacancies shall be considered as per Articles of Association (“AOA”) of the GJC and reservation rule shall be applicable as prescribed in the AOA and election rules.

Members please note that this is an electronic voting system and there is no human intervention involved in the voting system. Members has to use their registered 10 digit mobile number and a valid membership number available in our records to cast their votes in GJC Election 2020. Eligible members who wish to contest for the COA, has to submit the duly filled COA Nomination form available on website of GJC, duly Notarized Affidavit-Cum-Indemnity Bond printed on non-judicial stamp paper of Rs. 200/- or stamp duty of Rs. 200/- paid by way of franking and all the necessary documents along with enrolment fees of Rs. 5,000/- and a refundable deposit of Rs. 20,000/- (which will be refunded after the GJC Elections 2020 are done) in favour of **“All India Gem and Jewellery Domestic Council”** to be paid by way of DEMAND DRAFT payable at Mumbai/NEFT. The email shall be received on or before 15<sup>th</sup> December, 2020 by 5 p.m. and the original physical documents shall reach at GJC office not later than 16<sup>th</sup> December, 2020. Members sending the email shall also attach the copy of courier receipt/post acknowledgement evidencing that the original documents has been dispatched. E-mail received after 15<sup>th</sup> December, 2020 will not be accepted. Members are requested to read the Election Rules of GJC properly before participating for GJC Election 2020.

**Please Note:**

1. There will be no election for Zonal Chairman (West & North Zone) and Small Manufacturer-Jewellery Panel, since there are no vacancies under the said Zone and Panel.
2. There is no enrolment fees for casting your vote.
3. PAYMENT BY CHEQUE WILL NOT BE ACCEPTED.
4. Members shall send by registered post/recognized courier service their Nomination Form, Duly stamped and notarized Affidavit-Cum-Indemnity Bond with all other necessary required documents.
