2. The above Letter of Interest Form is only for seeking stalls in Hall no 1, 5 and 6 (which is Hall no 1, 2 and 3 as per new Layout of (BEC) a t Bombay Exhibition Centre, Goregaon East, Mumbai.
3. Only GJC members are permitted to participate in the show.
4. 1st Preference for allotment will be given to participants of Preferred Manufacturers of India (PMI) 5th edition, 2nd Preference will be given to Life Members of GJC, 3rd Preference will be given to Annual members of GJC.
